Phase II of the Building Grant was submitted on the 8th of October to the State₇.

<u>We</u> have received our first bill from the contractors (Bouley). <u>An Application for Certificate for Payment from Bouley Associates <u>was received</u> for \$128, 250.</u>

Baker & Taylor went under and has left many libraries in a quandary. We are going to use Ingram and Amazon to continue ordering books. Lisa has taken the old Baker & Taylor orders that have not arrived and reordered them through Ingram.

Thursday 10/9 a construction meeting was held.

Addendum was made to our Ground Lease with Opendore where we will not pay any shared expenses until the project is substantially complete. Betsy Donald made a motion to sign the Addendum and Kathie Garnsey seconded the motion. Motion carried to sign the Addendum. The Addendum was signed by both parties – Opendore and Hazard Library.
